WHO IS ELIGIBLE?

Extended First Offender Program (9 months) \$1,330	Those who have been convicted of a first DUI and have a blood alcohol level of .20 or higher within the past ten years.
First Offender Program (3 months) \$735	Those 21 years or older convicted of a first DUI Offense in the last ten years with a blood alcohol level less than .20.
Multiple Offender Program (18 months) \$2,345	Those who have been convicted of two or more DUI offenses in the past ten years.
Wet Reckless Program (2 months) \$350	Those 21 years or older convicted of a first DUI offense with a blood alcohol level of .08 or below.
Young Adult Program Level 1 (2 months) \$350	Those between 18 and 20 years old convicted of a first DUI offense with a blood alcohol level of .08 or below.
Young Adult Program Level 2 (3 months) \$735	Those between the ages of 18 and 20 years convicted of a first DUI Offense with a blood alcohol level less than .20

HOW IS A REFERRAL MADE?

The Court, DMV, or Probation may require completion of the program and you may attend either: a licensed program in your county of residence; or a licensed program in the county of conviction

COURT AND DMV REPORTING

- The Court may require periodic reports on any participant in the program.
- Upon program completion and the payment of all fees, the program returns a certificate of successful completion to the court of conviction and DMV. If you fail to register or participate appropriately, notification of termination for non-compliance may be forwarded to the court of conviction and DMV.

STEPS TO FOLLOW

- Go to the program office where you wish to enroll as soon as possible following referral.
- You may enroll between 9 am and 3 pm Monday through Friday at the Atascadero and Grover Beach Office. To enroll at the SLO office call 805-781-4753 to make an appointment to enroll. To save time download the DUI Forms you need by going to **www.slodas.org** and fill them out prior to coming in to enroll.
- Enrollment precedes program participation. Enrollment services are on a first come-first serve basis.
- **Bring your court paperwork; know your date of violation, and minimum \$200 to enroll.**
- Go to the address that you wish to attend (listed above).
